Title: County of Bruce Fonds.

Dates: 1850-2007.

Extent: 78 m of textual records. -- 184 photographs : b&w and col. -- 465 blueprints.

Administrative history: The Bruce County Fonds consists of Administrative records for the United Counties of Huron, Perth and Bruce (1850-1852), the United Counties of Huron and Bruce (1853-1866), the County of Bruce Provisional Council (1857-1866), and the County of Bruce (1867-2008).

The County of Bruce (popularly known as Bruce County) was established 1 January 1850 within The United Counties of Huron, Perth and Bruce, in the Province of Canada (later the province of Ontario, Canada). Referred to as the Queen's Bush before 23 May 1846 and part of the District of Huron until the end of 1849, the area north of Huron County and bordered by Georgian Bay and Lake Huron was named after James Bruce, Earl of Elgin and Kincardine, Governor General of Canada (1847-1854). After the departure of Perth County on 1 January 1853, the United Counties of Huron and Bruce governed until the County of Bruce was established as a separate municipality on 1 January 1867. Goderich was the county seat for the United Counties of Huron, Perth and Bruce from 1850-1852 as well as its successor body, the United Counties of Huron and Bruce from 1853-1866.

On 16 May 1856 Parliament allowed for the Provisional County Council of Bruce to form but due to disagreement over where to locate the County Town, Bruce County was not incorporated until 1867. During this divisive time Council was held in Paisley, Pinkerton, Southampton, Kincardine, and Walkerton, with the latter two locations holding many of the meetings and creating much of the discord. After 1867 the county seat was held in Walkerton although it was not officially established as a town until 15 February 1871.

The County of Bruce consisted of the following townships at its 1850 conception: Arran, Brant, Bruce, Carrick, Culross, Elderslie, Greenock, Huron, Kincardine, Kinloss, and Saugeen. Bruce County saw many incorporations and alterations to its lower-tier municipalities in the subsequent years including to Townships: Albermarle (1861; separated from Arran), Amabel (1861; separated from Arran), Eastnor (1855; united with Albermarle, 1869; united with Lindsay and St. Edmunds, 1873; separated from Albermarle, 1878; separated from Lindsay and St. Edmunds, 1883), Lindsay (1873; united with Albermarle, Eastnor, and St. Edmunds, 1873; separated from Albermarle, 1878; separated from Eastnor, 1883; separated from St. Edmunds, 1903), and St. Edmunds (1873, united with Albermarle, Eastnor, and Lindsay, 1873; separated from Albermarle, 1878; separated from Eastnor, 1883; separated from Lindsay, 1903); to Villages: Hepworth (1899), Lion's Head (1917), Lucknow (1863), Mildmay (1918), Paisley (1874), Ripley (1925), Tara (1881), Teeswater (1875), and Tiverton (1878); and to Towns: Chesley (1880), Kincardine (1858; known as Penetangore from 1848), Port Elgin (1874), Southampton (1858), Walkerton, (1871) and Warton (1880).

Through 1998-1999 the communities of Bruce County were amalgamated into the following bodies: Town of Saugeen Shores (Township of Saugeen, Town of Port Elgin, Town of Southampton), Town of South Bruce Peninsula (Township of Albemarle, Township of Amabel, Village of Hepworth, Town of Wiarton), Township of Huron-Kinloss (Township of Huron, Township of Kinsloss, Village of Lucknow, Village of Ripley), Municipality of Arran-Elderslie (Township of Arran, Township of Elderslie, Town of Chesley, Village of Tara, Village of Paisley), Municipality of Brockton (Township of Brant, Township of Greenock, Town of Walkerton), Municipality of Kincardine (Township of Kincardine, Township of Bruce, Town of Kincardine, Village of Tiverton), Municipality of Northern Bruce Peninsula (Township of Eastnor, Township of St. Edmund's, Township of Lindsay, Village of Lion's Head), and the Municipality of South Bruce (Township of Carrick, Township of Culross, Village of Mildmay, Village of Teeswater).

The County of Bruce is an upper-tier municipality under the Municipal Act of Ontario and as such has requisite responsibilities (reflected in the Scope and Content section) and a specific administrative hierarchy. Historically both towns and townships voted councilors to their municipal councils while the former elected mayors and the latter reeves. Since the 1999 countywide amalgamation all lower-tier heads of council have been referred to as mayors. The elected reeves and mayors became the county council who would then elect from their members the warden.

Custodial history: In 1984 these records were transferred to Bruce County Museum & Cultural Centre from the Bruce County Administration Building in Walkerton.
